**DEPOSIT:** A CHECK ONLY deposit of \$520.00 per person, is required to secure each reservation, in addition to booking your roundtrip flight to Tel Aviv, Israel from your place of origin. Please make your check payable to **ALTOUR TRAVEL**. Your flight can be booked with a credit card. Please provide your COMPLETED REGISTRATION FORM, and this TOUR CONDITIONS FORM, both signed, along with a copy of your PASSPORT face page, clearly showing your name, date of birth, expiration date and photo, prior to booking.

**FINAL PAYMENT:** On or before **FRIDAY NOV 1, 2024**, as provided in the Registration form via personal check made out to tour leader "Christopher Cross".

**TOUR PRICES:** Tour prices are per person, based on two persons sharing a room. Private Rooms cost extra, and for those rates, please see the Registration Form. There are a limited number of single occupancy private rooms, which will be filled on a first come first serve basis.

**CANCELLATIONS AND FEES PER PERSON:** \$350.00 per person of each deposit is non-refundable, until end of business day, **FRIDAY NOV 1, 2024**. Thereafter, the entire deposit and any Final Payment, or portions thereof as tendered, become entirely non-refundable.

**TRAVEL INSURANCE** is highly recommended. (See Altour Travel agent for further information)

**PASSPORTS: U. S. Citizens - a valid passport is needed for travel.** PASSPORTS must be valid through AUGUST 30, 2024 (6 MONTHS beyond your return date). **Please advise your ALTOUR travel agent immediately if you are not traveling with a U.S. Passport**, so any pre-travel entry VISA requirements can be determined. If you do not yet have a passport, REGISTER under your complete legal name, as you intend your name to appear on your passport, and then apply immediately through the US State Department. Passport initial issue or renewal or replacement times may vary with State Department backlog or the specifics of your particular situation.

**SPECIAL ASSISTANCE:** Please advise if you have special needs so that we can see if they can be accommodated. As to the Land Portion, a person must be able to move at a reasonable pace and walk 4-5miles each day, every day. There are frequent rests in between walks and frequent bathroom access. Wheelchair access is not available.

**SMOKING:** Smoking is not allowed on all FLIGHTS and all BUSSES.

**BAGGAGE WITH AIRLINES:** One free carry-on bag per person and one free check-in bag per person is the norm with US based airlines. **Please check with your chosen Airline for their specific baggage allowances.**

**NOT INCLUDED IN THE TOUR PRICE ARE:** Tips for the Guide, Driver and other Service personal such as waiters.

The tour participant agrees that neither ALTOUR nor its affiliates shall be liable for any damage, loss (including personal injury, death and property loss) or expense occasioned by any act or omission of any supplier providing tour services, or of any other person.
